Privacy Policy

Objective

To explain the SALSA policy regarding the personal information we collect about you. Your privacy is important to us. Please read this statement to learn about the ways we protect your personal information. This statement does not, and is not intended to create any contractual or other legal rights.

General

We will only use your personal information to improve the service that we provide to you and to our stakeholders. This Privacy Policy fully complies with the UK General Data Protection Regulation (UK GDPR) tailored by the Data Protection Act 2018 and we will, within reason, ensure that your information is secure and monitored with regard to access, both internally and externally. The personal information you submit through our website www.salsafood.co.uk or by any other means will be collected and safeguarded by Salsa Technologies Ltd. located at Bloxham Mill, Barford Road, Bloxham, Banbury, OX15 4FF.

Personal Data

The personal data that you submit to SALSA via this website or any other means may be kept on our database and will not be released to a third party. At some point, you may be given the option to receive information from SALSA about other products and services via email or post. If you opt not to receive such communications, you will only receive the information that is directly relevant to you, which you have provided consent to receive.. You will be given access, through a secure user identity and password, to your personal data and will have the opportunity to update, change or remove this information.

Third parties and Public Access

SALSA never sells or otherwise passes on your personal information to third parties. We only ask for and collect personal information that we feel is necessary to fulfil the service that we provide through SALSA. Personal details about you, found on the SALSA website are published only with your permission. You can withdraw your consent at any time by contacting info@salsafood.co.uk.

Any information collected as part of the planning or delivery of an audit, remains confidential between SALSA and the member. However, any information received which indicates potential fraud or criminality shall be shared with the relevant authorities (eg Food Standards Agency or EHO Primary Authority). Any requests made by Authorities for information in relation to food safety prosecution must be released in line with UK legislation.

Security

SALSA has taken appropriate technical and organisational measures to ensure we have mitigated against such risks as loss or unauthorised access, destruction, use, modification or disclosure of data, to ensure the 'confidentiality, integrity and availability' of your personal data. However, you should be aware that 'perfect security' does not exist on the Internet.

SALSA provides links to selected other sites over which we have no control and we have no responsibility for their Privacy Policies. If you follow such a link from this site to another site, this Policy will no longer apply.

Other Information Collected

We may use your internet provider address/domain name or computer IP address to collect anonymous aggregated statistics regarding numbers of visitors, countries of origin, pages visited, machine information and other similar site statistics. We may also record the URL you just came from and which URL you next go to when entering and leaving our website. These statistics cannot be traced back to individual users. We use them to ensure that we are providing a good service to our users and to keep track of and resolve any technical difficulties.
